### **ONA80 Local Coordinator update**

#### Federal and Ontario political update

The federal government signaled expanded health spending, including extension of the Canadian Dental Care Plan to uninsured adults aged 18–64. Pharmacare expansion remains limited to an initial formulary, prompting continued advocacy for a comprehensive national program (Ontario Nurses' Association, 2025 Pre-Budget Submission: https://www.ona.org/wpcontent/uploads/2025/01/ONA\_govtsub\_2025PreBudgetSubmission\_20250129.pdf).

Ontario's 2025 Budget, titled "A Plan to Protect Ontario," was tabled May 15 by Finance Minister Peter Bethlenfalvy, identifying tariff uncertainty, population growth, interest rates, and inflation as key pressures.

#### Provincial and regional meetings (April-October 2025)

Provincial Leadership Meeting – April 15–16, 2025 (Sheraton Centre Hotel, Toronto) ONA80 was represented by Executive members and members-at-large.

Discussions focused on hospital bargaining priorities, staffing ratios campaign, and political updates. It was an important opportunity for Locals to coordinate messaging and prepare for the Biennial Convention.

BC, Alberta and Manitoba took the steps to address nursing ratios.

ONA80 was represented by members of Executive and 1 unit-level rep.

Engaging discussions took place based on real cases from workplaces. Many focused on violence reporting, mental health supports, and employer responsibilities under the OHSA. Good participation.



June Provincial Coordinators Meeting – June 10–12, 2025 (Hilton Toronto/Markham Hotel)

Hosted by Region 3

Locals across the region took part in planning the event and preparing materials. ONA6, ONA82, ONA80, and ONA51 were part of the planning committee.

The PCM ran over three full days of business and was attended by members of the ONA80 Executive and ONA80 reps and members.

To improve accessibility to this provincial leadership meeting hosted in our region, the Local offered salary replacement for the first 10 members attending on LOA. An additional maximum of 10 LOA days were offered to members attending on their own time.

A number of ONA80 members and reps took the opportunity to attend as it was hosted here in region 3.

- Labour Relations updates
- Provincial Bargaining developments

#### Region 3 ACC:

Region 3 consists of 14 Locals. Local Coordinators meet 3 times a year to share reports from their Locals and receive important updates from ONA staff and portfolio stakeholders.

These meetings are the networking hub to bring forward important issues and share with all leaders across the region.

In preparation all Locals submit e-scans. These reports are reviewed by the panel and discussed helping the Board of Directors develop action plans for all five regions based on real-time issues and trends.

- Key discussions focused on significant challenges, including:
  - o Grievances and labour relations issues, particularly discipline and terminations




- Support for Internationally Educated Nurses (IENs), which remains insufficient from both the government and employers.
- Rising workloads, a new approach developed by ONA to assign Practice Specialists and Labour Relations Officers (LROs) to assist with workload concerns.
- Vacancy rates, retention issues, and denied time-off requests, all of which continue to impact members across the region.

#### Education, engagement, and finances

We remain on track to allocate about 10% of the Local budget to education. The honorarium for attending ONA workshops or meetings was increased from \$100 to \$150. A new 2025 practice allows up to 10 members to attend Leadership Meetings (in addition to Biennial) with salary replacement. The Local continues reimbursing public transit or public parking for PLM, PCM, and related meetings.

ONA80 assisting North York community to provide dinner to kids without shelter outreach project

Using our 26.11 funds, ONA80 partnered with community stakeholders to deliver dinners to kids without shelter in North York, reflecting our commitment to social justice beyond the workplace.



#### **Hospital Bargaining Update**

After four days of arbitration (April 2, 3, 14 and 17),

Arbitrator Price has released a decision for the 2025 hospital sector bargaining that affects more than 60,000 hospital members. The decision is a two-year contract that covers term from April 1, 2025, to March 31, 2027.

Ontario Nurses' Association condemns hospital arbitration decision as a betrayal of 60,000 nurses and meaningful collective bargaining ONA Provincial President Erin Ariss, RN, says arbitrator Sheri Price's decision "sets a new low in the history of bargaining for Ontario's nurses. Price's failure to deliver safe staffing ratios sends a clear message to Ontario nurses that we do not deserve the same safety in numbers that other front-line workers in dangerous professions like police and firefighters – are afforded. It tells a workforce that is overwhelmingly women that the unchecked and brutal violence we face every day is acceptable, and our safety is not important. As nurses, as women, as workers, we will not accept this."
